### ADDRESSING HOUSING INSECURITY

Heading Home of South Central Indiana works to reduce homelessness and strengthen housing security. In 2022-23, this community collaboration provided trainings for case managers, hosted a Bloomington mayoral candidate forum, and launched a housing resource guide, among other projects.

Looking ahead, Heading Home will continue its partnership with the national Built for Zero initiative, increase landlord support, publish a public data dashboard to track progress in decreasing homelessness, and work to de-stigmatize housing insecurity.

### EMERGENCY FOOD AND SHELTER PROGRAM

United Way partners with the Federal Emergency Management Agency to address local needs through the Emergency Food and Shelter Program. Regional volunteers evaluate applications and make funding decisions. In 2022, United Way was awarded and distributed:


